### 3 QUALIFICATION REQUIREMENTS

#### FULL MEMBERSHIP (includes INTERNS and GRADUATES)

Full Membership with the RAIC is reserved for individuals with formally defined qualifications in the field of architecture. The qualifications acceptable for Full Membership are as follows:

- (i) active or retired members of a Canadian provincial architectural licensing organization; or
- (ii) individuals who have been certified by the Canadian Architectural Certification Board (CACB); or
- (iii) graduates of the RAIC Syllabus of Studies who have obtained CACB certification; or
- (iv) graduates from a professional degree program at a Canadian University School of Architecture on or before June 30, 1995; or
- (v) graduates of a CACB-accredited professional degree program after June 30, 1995; or
- (vi) graduates from a foreign school of architecture at the discretion of the Board. The following items are to be provided for Full Membership:
  - A letter of support from an RAIC member,
  - Proof of residency in Canada,
  - A résumé confirming education and experience,
  - Confirmation of employment within the design and construction sector,
  - A copy of an architecture diploma or degree from a foreign institute; or
- (vii) on the recommendation of the Program Head, the holder of an academic appointment at a Canadian University School of Architecture.
