A defining moment for the Board this year was selecting the late Honorable Justice Murray Sinclair as the recipient of the 2024 RAIC Gold Medal, the Institute's highest honour. This decision underscores our commitment to leadership that advances truth, reconciliation, and social justice. Justice Sinclair's profound contributions continue to inspire more inclusive and culturally sensitive design practices, challenging our profession to think beyond traditional boundaries.

Looking forward to 2025, we remain steadfast in our strategic vision. We will continue to support our members and broader community, challenge conventional practices, and position Canadian architecture at the forefront of global innovation and sustainable design. Strengthening our impact also means communicating with greater clarity and intention—ensuring our messages resonate with diverse audiences and reflect the depth and diversity of our actions.

Our journey is defined by collaboration and resilience. Together, we are not only building structures—we are shaping a future where architecture is a force for inclusion, sustainability and cultural richness across Canada and beyond.

CEO'S REPORT

THE PAST YEAR HAS BEEN TRANSFORMATIVE FOR OUR

ORGANIZATION, marked by significant achievements and strategic developments across multiple fronts. We have made substantial progress in advancing architectural excellence, advocacy, and sustainability.

The 2024 RAIC Conference on Architecture, held in Vancouver, welcomed over 1000 architectural professionals from across Canada for five days of learning, collaboration, and inspiration. The 2024 Congress on Architecture, held in St. Andrews, focused on advancing our Climate Action Plan, particularly in relation to the housing, affordability, and climate crises.

We've actively engaged with federal and provincial governments to promote progressive policies, including:

- Climate-conscious building codes
- Sustainable procurement practices
- Increased support for affordable housing

Internationally, our work with the International Union of Architects (UIA) and the Indigenous Peoples' Work Program continues to exemplify our commitment to global and local architectural dialogue.

Internally, we have maintained a strong and stable team, dedicated to delivering high quality services to our members. Our digital presence has expanded, enabling us to reach broader audiences through enhanced communications, webinars, and publications.

A key highlight this year was the evolution of our Honours and Awards program, which now recognizes excellence in sustainability practices and Indigenous-led design. Notably, the Governor General's Medals expanded its submission criteria to include sustainability data, and the 2024 International Prize was awarded to Ngā Aho, a national network of Māori design professionals based in Aotearoa, New Zealand.

Additionally, 2024 served as a catalyst for meaningful change for the RAIC Syllabus program. A three-year revitalization plan is now underway to ensure that architectural education remains accessible, relevant, and progressive.

One critical lesson from our 2022-2024 strategic planning exercise has been the importance of comprehensively integrating design excellence into all aspects of our work. To achieve this, we have developed tactical approaches that transform this concept from an abstract ideal into a concrete, actionable principle.

The challenges of the post-pandemic landscape have only strengthened our resolve. We are adapting, innovating, and continuing to push the boundaries of architectural practice with resilience and vision.

As we move into 2025, I extend my deepest gratitude to our volunteers, partners, and members for their tireless support of the RAIC's mission. We remain committed to driving positive change in the architectural profession, with a strong focus on innovation, sustainability, truth and reconciliation, and professional growth for architects across Canada.

Together, we are shaping the future of Canadian architecture and its role in creating a more sustainable, equitable, and inspiring built environment.

CELEBRATING EXCELLENCE: HONOURS & AWARDS

In 2024, the RAIC's national awards program received some outstanding submissions from the architectural community in Canada. The program was able to not only showcase these achievements but also boost public awareness about the built environment and the professionals involved in it.

Most notably, the International Prize expanded to embrace RAIC's evolving mission across Canada, focusing on "Indigenous Architecture" to celebrate practitioners who incorporate Indigenous knowledge in their work, aligning with the Truth and Reconciliation Commission of Canada's principles established since 2008.





- Held three "Aging in Place" workshops, designed for seniors and near-seniors who want to stay in their homes as they age.




EMPOWERING PRACTICE: TOOLS & RESOURCES FOR SUCCESS

RAIC ADVISORS TO PROFESSIONAL PRACTICE

In 2024, the RAIC continued to strengthen the RAIC Advisors to Professional Practice (RAPP) initiative, reinforcing its commitment to supporting Canada's architectural community through expert knowledge and collaboration. RAPP brings together subject matter experts—including architects, educators, and allied professionals—to develop, refine, and maintain essential resources that enhance architectural practice across the country.

By providing valuable insights into the evolving landscape and challenges of architectural practice, RAPP plays a key role in shaping RAIC's advocacy efforts and professional advisory services. This initiative fosters excellence within the profession by ensuring that architects have access to informed guidance, best practices, and a network of expertise.



DIGITAL CONTRACTS

In 2024, the RAIC enhanced its Digital Contracts system with a series of upgrades and performance improvements to streamline usability and efficiency. To support users, the RAIC also hosted informational training sessions, offering an in-depth overview of the contracts and addressing common questions through dedicated FAQ sessions. These efforts aimed to ensure that architects and industry professionals can navigate the system with ease and confidence.

JUNE

CHAMPIONING ARCHITECTURE: OUR ADVOCACY JOURNEY

The RAIC has actively championed advocacy efforts at both the federal, provincial, and municipal levels, working to influence key decisions early in the process. Recent initiatives have focused on shaping policy frameworks, supporting sustainable practices, advocating for better procurement, and addressing other critical issues impacting the architectural community.

COLLABORATION AND ACTION:

Annual Forum of the Canadian Public Procurement Council

RAIC Advisors to Professional Practice (RAPP) Yew-Thong Leong and Lawrence Bird participated in the Annual Forum of the Canadian Public Procurement Council (CPPC), presenting on the subject of architectural RFPs. The CPPC is an industry group that includes key federal and provincial agencies tasked with the procurement of architectural services, as well as notable private sector entities with the same role. The talk was titled "Professional Architectural Services Contracts Done Right: The Good, Bad and Ugly". The goals of this session included connecting with key agencies involved in architectural procurement, communicating to them some of the vagaries of the RFP process from architects' point of view, and advocating for RFPs that work equally well for clients and practitioners.

SOSA x RAIC: Spotlight South Asia 2024

On May 2, 2024, the RAIC partnered with the Society of South Asian Architects (SOSA) to host a panel discussion at Toronto Metropolitan University. The event celebrated South Asian Heritage Month and featured speakers Omar Gandhi and Mansoor Kazerouni, sharing their professional journeys and insights.

FPAA Extended Executive Committee Meeting

From May 11 to 13, 2024, the RAIC hosted the executive committee of the Pan American Federation of Architects Associations (FPAA) in Vancouver. This meeting, preceding the 2024 Conference on Architecture, focused on strategic discussions regarding the future of architecture in the Americas.

RAIC and NRC Partner for Knowledge Mobilization Project - Life Cycle Assessment

Partnering with the National Research Council of Canada (NRC) and Ha/f Climate Design, the RAIC deployed a one-year rapid-deployment project to train members of the Canadian architectural community through a high quality, hands-on, case-study-based Whole Building Life Cycle Assessment (LCA) curriculum. Whole Building LCA provides an estimate of the total GHG emissions associated with a building. The workshops were held between September 2024 and May 2025 in various locations across Canada including Ottawa, Toronto, Saint Andrews, Winnipeg, Regina, Vancouver, Calgary, Halifax, and Montréal.

RAIC 2024 Congress on Architecture

Held on October 7-8, 2024, in Saint Andrews, New Brunswick, this event explored the intersection of housing, affordability, and the climate crises and examine how Canada can move toward holistic solutions to this interconnected crisis. It featured panel discussions and networking opportunities, including a Whole Building Life Cycle Assessment workshop in collaboration with the National Research Council of Canada (NRC).

FPAA Forum in Mexico

From October 14 to 17, 2024, the RAIC participated in the XXVII Pan American Congress of Architects, hosted by the Pan American Federation of Architects Associations (FPAA) and the Federación de Colegios de Arquitectos de la República Mexicana (FCARM) in Mexico City. Themed "Architecture Between Limits," the Congress brought together architectural leaders, emerging professionals, and academics to explore contemporary challenges in the built environment. The event featured a book presentation marking FPAA's 100th anniversary, the FPAA Architecture Awards, a series of lectures, and the Pan American Architecture Exhibition. Alongside the Congress, the RAIC also engaged with industry leaders at the Obra Blanca Expo 2024, which showcased innovations in finishes and design products.

UIA 2024 International Forum in Kuala Lumpur

From November 15 to 19, 2024, the RAIC played a key role at the International Union of Architects (UIA) Forum in Kuala Lumpur. Serving as the secretariat for the UIA Indigenous Peoples Work Program (IPWP), the RAIC hosted a dynamic presence at the tradeshow, including engaging "Booth Talks" and a well-received formal panel session. These activities offered architects from around the world the opportunity to explore Indigenous architectural philosophies and practices. Additionally, the RAIC engaged in strategic discussions with leading architectural organizations globally, reaffirming its dedication to maintaining architectural excellence and ethical practice on a global scale.

Polish-Canadian Architectural Exhibition

RAIC President Jonathan Bisson represented the organization at the opening of the "Architecture Without Borders – Polish-Canadian Architectural Exhibition – Vancouver 2024/25", at the Museum of Vancouver, showcasing the contributions of Polish experts to the field of architecture in British Columbia and beyond.

Participation in Architectes Sans Frontières Québec's "La Soirée des Grands A"

On November 27, 2024, the RAIC participated in "La Soirée des Grands A," hosted by Architectes Sans Frontières Québec (ASFQ) at the Montreal Science Centre. The event, themed "Against the Current," addressed environmental challenges such as floods and other crises, providing a platform for networking and discussing innovative architectural solutions.

DRIVING CHANGE: TASK FORCES, WORKING GROUPS & COMMITTEES IN ACTION

INDIGENOUS TASK FORCE (ITF)

In 2024, the ITF furthered its initiatives and advocacy for Indigenous representation in the architectural profession. Through these efforts, the ITF continues to build on its foundational goals of advancing Indigenous voices and perspectives in the Canadian architecture community.

Key activities in 2024 include:

- Indigenous Members Directory: Continued the quarterly review and updates of the RAIC
 Indigenous Member Directory. Requests for the directory by external stakeholders were reviewed and
 approved by the ITF.
- National Day for Truth and Reconciliation (NDTR): Supported planning of the RAIC commemoration of the 2024 NDTR. David Fortin led a session "Reconciling with Reconciliation" with an audience of 300+ attendees.
- 2024 International Prize: The Task Force helped select Ngā Aho, a national network of Māori design professionals based in Aotearoa (New Zealand), as the 2024 prize recipient in recognition of their exceptional contributions to Indigenous architecture.
- Indigenous Task Force Meetings: Held recurring monthly meetings, continuing the process of reviewing and updating the ITF Terms of Reference.
- Conference 2024: Several ITF members met with Huia Reriti, President of the New Zealand Institute
 of Architects (NZIA), and several members of Ngā Aho. The discussions focused on strengthening
 international Indigenous relations and exploring collaborative efforts in the global architectural community.
- UIA Indigenous Peoples Work Programme (IPWP): ITF members contributed to an interactive
 experience for the International Union of Architects (UIA) Forum in Kuala Lumpur. The IPWP hosted a
 presence at the trade show, which included several "Booth Talks" and a formal panel discussion.



TRUTH AND RECONCILIATION TASK FORCE (TRTF)

The TRTF carried on its mandate to facilitate sustainable actions fostering reconciliation within the architectural profession. On September 27, 2024, to commemorate the National Day for Truth and Reconciliation, the RAIC hosted an online event titled "Reconciling Reconciliation Through Design," presented by David Fortin. This session explored the integration of Indigenous perspectives in architectural design and was made available as an on-demand webinar for broader accessibility.

COMMITTEE ON REGENERATIVE ENVIRONMENTS (CORE)

The CORE continued to enhance the architectural profession's capacity to address complex, systemic challenges through regenerative design practices. In 2024, CORE achieved the following:

- Climate Action Engagement and Enablement Plan (CAEEP) Development: At the RAIC Conference on Architecture in Vancouver in May 2024, CORE's Climate Action Engagement and Enablement Plan Steering Committee (CAEEP SC) launched a first view of the Climate Action Plan. They also hosted a session at Conference The "RAIC Climate Action Plan Supporting the Transformation of Practice." CAEEP SC wound down its work in September 2024 with all work reverting to CORE.
- RAIC Congress on Architecture 2024: On October 2, 2024, coinciding with World Architecture
 Day, CORE played a key role in the RAIC Congress on Architecture, held in Saint Andrews, New
 Brunswick. The event focused on climate action and architecture, providing a platform for
 professionals to discuss and promote regenerative design practices.

PROMOTING EQUITY AND JUSTICE ADVISORY COMMITTEE (PEJ-AC)

In 2024, the PEJ-AC hosted an online webinar, "Invisible Disabilities in Architecture: Fostering Inclusion in Education and Design," on how architectural education can better address invisible disabilities, advocating for the incorporation of disability perspectives and culture in pedagogy and curriculum.

FEES & PROCUREMENT WORKING GROUP (FPWG)

In 2024, the FPWG was involved in developing resources and strategies to help architects navigate procurement processes and establish appropriate fee structures.

- Cost Calculator Development: Providing guidance to the development of a member-exclusive construction cost calculator tool to be launched in 2025.
- RFP Best Practices: Providing guidance on the development of a member-exclusive RFP review process to be launched in 2025.

LONG TERM CARE DESIGN WORKING GROUP (LTC-WG)

In 2024, the LTC-WG, as the advisory entity on strategies to enhance the dignity, health, safety, and well-being of residents, staff, and visitors in long-term care facilities, helped plan a webinar series on the subject and reviewed and identified trends in long-term care.

PROFESSIONAL PRACTICE WORKING GROUP (PPWG)

Established in 2024, the Professional Practice Working Group (PPWG) plays a critical role in supporting Canadian architectural practice through the development and maintenance of essential resources. Under the leadership of the RAIC's advocacy and practice support initiatives, the PPWG focuses on standard contracts, fee guidelines, and other key documents that contribute to best practices in the profession.

The PPWG's key activities in 2024 included:

- Reviewing CCDC Documents: Provided feedback on multiple CCDC documents.
- New Practice Product: Supporting the development the construction cost calculator



TREASURER'S REPORT

I AM PLEASED TO PRESENT THE FINANCIAL PERFORMANCE

of the RAIC for the year ended December 31, 2024. This report reflects the organization's continued commitment to sound financial stewardship and our shared mission to support and advance the architectural profession in Canada. Through careful planning and strategic investment, we have ensured that RAIC remains financially resilient and well-positioned for the future.

Financial Highlights

In 2024, the RAIC achieved total revenue of \$5,485,765, an increase of 30% from \$4,032,160 in 2023. This growth was primarily driven by key initiatives including Grants and Contracts, Membership Development & Services, and the RAIC Conference & Congress. On the expense side, the total increased to \$5,465,048, up 27.5% from \$4,145,443 in the prior year.

The organization recorded a net surplus of **\$20,717** for the year, a positive outcome that reflects well on our current financial plan. Unrestricted net assets now total **\$954,428**, providing a solid foundation for continued growth and innovation.

Cash Flow Position

At year-end, the RAIC's **cash reserves increased to \$1,187,202**, up from **\$1,079,585** in 2023. This improvement resulted from prudent management of accounts receivable and a modest increase in deferred revenue, thereby reinforcing the organization's strong liquidity position. It is our goal to have a cash reserve equal to six months operating funds in the bank as per standard accounting practice.

Asset Management

In 2024, the RAIC made **strategic investments totaling \$83,906** in tangible and intangible assets, with a focus on digital contracts and the website/branding initiative. Amortization expenses for the year totaled **\$50,952**, in line with our planned investment cycle and commitment to operational enhancement.

Outlook for 2025

Looking ahead, the RAIC remains committed to maintaining financial stability while expanding the reach and impact of our initiatives. With continued oversight and strategic focus, we anticipate further strengthening our financial position and enhancing value for members. Our priorities include expanding digital offerings, increasing member engagement, and securing diversified revenue sources to support innovation and growth.

We are grateful to our members, staff, and partners for their dedication and look forward to building on this momentum in the year ahead.
